Any failure by a user to comply with the terms and conditions contained herein may result in the immediate revocation of this license, in addition to any other sanctions and legal remedies imposed by AFCC. The interpretation and enforcement (or lack thereof) of these terms and conditions, and compliance with them, shall be made by AFCC in its sole discretion.
  2. The logos are made available to AFCC members in good standing in color and in black-and-white. The logos may not be revised or altered in any way, and must be displayed in the same form as produced by AFCC. The various classes of membership (charter, accredited, preferred, and associate) will be determined exclusively by AFCC and the Member may only display the designated class of membership as determined by AFCC.
  3.
